The Rusk County Emergency Service District #1 met on this date at 6:25 p.m. for a called Budget Workshop with Board President David Burks presiding. Board Members present were Brian Bathke, Gloria Dooley, Jiffy Dukes and Wayne Griffith. The meeting was opened with a prayer from Chief Don Reynolds, followed by the pledge to the American flag.

Departments present at the workshop were: Carlisle Henderson, Elderville, Crims Chapel, Church Hill, Mt. Enterprise, New Salem, New London, Laneville, Tatum, Eastside, Overton, Rusk County Rescue, and Reklaw. Kilgore FD and Kilgore Rescue were absent.

The first item under New Business was to appoint a Budget Workshop officer and Board President David Burks nominated Board Treasurer Gloria Dooley. Board Member Jiffy Dukes seconded the motion for nomination and the Board approved the nomination with a unanimous vote.

Board Treasurer Dooley then presented for review and discussions budgets from all departments as well as the Fire Marshall for 2023. Kilgore FD and Kilgore Rescue had emailed that they were not going to be seeking any additional funding and had not submitted hard budgets for review.
